Disaster Recovery Allowance

WHO CAN GET IT?

Disaster Recovery Allowance is an income support payment that can be paid for a maximum of 13-weeks if you have lost income due to **Ex-Tropical Cyclone Ellie** (**December 2022 - January 2023**).

This payment is available to employees or sole traders.

You must work or live in one of the following declared Local Government Areas:

- Derby West Kimberley
- Broome
- Halls Creek
- Wyndham East Kimberley

You must be able to prove you have lost income due to the disaster.

You must also be:

- 16 years and older
- not receiving an allowance or pension from Centrelink or Veteran Affairs
- meet residence rules (different from other Centrelink payments) by either
 - being an Australian permanent resident
 - holding an eligible visa and living in Australia

You have until 6 July 2023 to make a claim.

HOW DO I GET IT?

- Use your MyGov account linked to your Centrelink online account
- If you can't use your Centrelink online account, you can call Centrelink on 180 22 66 for help.
- Go into your local Centrelink office, agent or access point to use their computers and WIFI. (They can't lodge claims for you).

WHAT INFORMATION DO I NEED TO GIVE TO CENTRELINK?

Centrelink will ask you for evidence of your loss of income.

If you earn the same income each week/fortnight you need documents that show your income for 4 weeks before the ex-tropical cyclone (from 28 December 2022).

If your income changes each week, they may ask you to show your income for 8 weeks before the ex-tropical cyclone (from 28 December 2022).

Evidence could include:

- Payslips from your employer; or
- Bank statements showing previous payments from your employer; or
- A letter from your employer.

WHAT CAN I DO IF CENTRELINK REJECTS MY CLAIM?

- Ask for an urgent formal review of that decision by an Authorised Review Officer. See our factsheet titled <u>'Appealing Decisions – Centrelink'</u> for more information - <u>Welfare Rights & Advocacy Service (WA)</u>

WHAT OTHER PAYMENTS COULD I BE ELIGIBLE FOR?

Disaster Recovery Payment

You may be able to get this one-off payment if you

- Live in the Derby West Kimberley Local Government Area; and
- Were 'adversely affected' by Ex-Tropical Cyclone Ellie.

Advance Payments

You can ask of an advance on your current Centrelink payments. This is a loan which you will have to repay every fortnight.

If you have a Centrelink debt, you are not eligible for an advance.

Crisis Payment for Extreme Circumstances

You may be able to get this one-off payment equivalent of your usual Centrelink income if you

- Are in severe financial hardship;
- Have had to relocate; and
- Are not covered by a disaster relief payment.

You must make a claim within 7 days of relocating.

You can only claim a maximum of 4 crisis payments per year.
